- Your passport, birth certificate and/or residency papers.
- · The municipality will register you and you will be issued with a BSN.
- During the period before you attend an appointment with the IND, accommodation and other things you need will be provided on a provisional basis. No rights can be derived from this.

Within 4 weeks after registration



Make an appointment with the IND

You will make an appointment with the IND within 4 weeks via the online planner (ind.nl). Sometimes the municipality will make the appointment on your behalf.

The IND will assess whether you are eligible for protection under the RTB (European Temporary Protection Directive (Richtlijn Tijdelijke Bescherming)). Have you not had an appointment with the IND within 4 weeks?



If this is the case, you will receive a notification of the intention to stop processing your application for protection under the RTB. This means

that the IND intends to issue an opinion that you are not entitled to temporary protection. After receiving this notification you will have 4 weeks to respond or make

you a decision stating that your application for temporary protection has been rejected. i If you need legal assistance, you can contact the <u>Dutch Council</u>


